## Our Process

We follow a structured, collaborative approach to ensure meaningful results and actionable insights:

1. **Initial Consultation:** We meet with stakeholders to clarify goals, timeline, and resources, and to establish mutual expectations. This meeting can also be used for incorporating our evaluation services and deliverables into grant applications.
2. **Planning and Design:** We co-develop logic models or theory of change maps, identify evaluation questions, and select appropriate methods.
3. **Instrument Development:** We draft, test, and finalize data-collection tools—surveys, interview guides, focus-group protocols—ensuring cultural relevance and technical rigor.
4. **Data Collection:** Our team implements mixed-method data-gathering strategies, coordinating schedules, recruiting participants, and maintaining data quality.
5. **Analysis and Interpretation:** We apply statistical and thematic analysis techniques, interpreting findings in light of program objectives and stakeholder needs.
6. **Reporting and Dissemination:** We deliver clear, visually engaging reports and presentations, highlighting key outcomes, lessons learned, and recommendations.
7. **Capacity-Building and Follow-Up:** We provide training workshops, one-on-one coaching, and ongoing technical assistance to strengthen internal evaluation capacity and support continuous improvement.
